1.1. WATER RESOURCES

1.1.1. WATER RESOURCES

Australia's water resources are highly variable, and range from heavily regulated working rivers and groundwater resources through to rivers and aquifers in almost pristine condition.

On average, 90 per cent of rainfall is directly evaporated back to the atmosphere or used by plants; only 10 per cent becomes runoff into rivers or recharge into groundwater aquifers. This runoff and recharge is highly variable, resulting in significant differences in water availability across Australia. Groundwater makes up nearly one-fifth of Australia's 'sustainable' water resources.

In 2004-05, total runoff was estimated at 242.8km³ and total groundwater recharge at 49.2km³. This gives a total inflow to Australia's surface and groundwater resources of 292km³ (10 per cent of rainfall). Based on these figures, runoff to rivers made up 83 per cent of total inflows, and groundwater recharge accounted for 17 per cent.

Runoff is not evenly distributed across the country. In 2004-05, more than 60 per cent of Australia's total runoff was in Australia's three northern drainage divisions:

- Gulf of Carpentaria drainage division (62.1km³);
- Timor Sea drainage division (50.2km³);
- North-East Coast drainage division (40.2km³);

In contrast, the Murray-Darling Basin was relatively dry, accounting for only six per cent of Australia's runoff in 2004-05.

There are 501 large dams in Australia. In 2004-05 the total storage capacity of these dams was 83.8km³. In addition to large dams, there are more than two million farm dams across Australia. These dams are estimated to have a total storage capacity of 8km³.

Groundwater makes up approximately 17 per cent of Australia's 'sustainable' water resources. Much of Australia's groundwater is drawn from the Great Artesian Basin – the largest groundwater reserve of its type in the world. It covers 22 per cent of the Australian continent and contains water that is up to two million years old.

Determining how much groundwater is available is difficult. Compared to surface water systems, we know little about groundwater systems and, in many areas across Australia, surface water and groundwater resources are physically connected (for example, a lake might recharge a groundwater system, or groundwater might keep a river flowing when it is not raining).

1.1.2. WATER USE

Water consumption in 2004-05 was 18.8km³. The sectors of the economy that used this water

were:

- agriculture: 65 per cent (12.2km³);
- household: 11 per cent (2.1km³);
- water supply industry: 11 per cent (2.1km³);
- other industries (including electricity and gas): 7.4 per cent (1.3km³);
- manufacturing: 3 per cent (0.6km³);
- mining: 2 per cent (0.4km³).

Of the water used by agriculture, most was used for irrigation of crops and pastures.

Household water consumption equates to 104m³ of water per person per year, or 0.29m³ per person per day.

Due to dry conditions and limited water availability, water consumption in Australia decreased by nearly 3km³, or 14 per cent, between 2000-01 and 2004-05.

Over the same period:

- agricultural consumption was down 23 per cent, largely due to the reduction in rice and cotton crops;
- household consumption decreased 8 per cent, to 103m³ per person;
- household use of reused or recycled water increased from 11 per cent to 16 per cent;
- mining industry water use increased by 29 per cent, due to increased levels of mining activity, particularly in Western Australia;
- nearly all (90 per cent) of the water used for agriculture in 2007-08 was used for irrigation. Pastures and crops used for grazing continued to be the largest users of irrigated water (26 per cent). Other high irrigation users were cereal crops for grain and seed, excluding rice, which used 15 per cent of irrigation water, and sugar cane, which used nearly 14 per cent.

Rice was the most heavily irrigated crop in 2007-08, in terms of the volume of water applied per unit area. The application rate for rice was almost four times the national average rate across all crops and pastures. Cotton was the crop with the second highest irrigation rate.

1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Australia's major environmental problems are: soil erosion from overgrazing, industrial development, urbanization, and poor farming practices; soil salinity rising due to the use of poor-quality water; desertification; clearing for agricultural purposes, which threatens the natural habitat of many unique animal and plant species; increased shipping and tourism, which threatens the Great Barrier Reef off the northeast coast, the largest coral reef in the world; limited natural fresh water resources.

The National Water Quality Management Strategy (NWQMS) provides the information and tools to help communities manage their water resources to meet current and future needs. It provides policies, a process and a series of national guidelines for water quality management. The Water

Quality Management Framework includes a step-by-step approach to planning, implementing and managing water quality for each area, plus information about common environmental stressors. More than 80 per cent of the river length that was assessed across Australia was affected by catchment disturbance. The least affected reaches were in Tasmania and the Northern Territory. Hydrologic change could be assessed in only 25 per cent of the river length, due to a lack of data. In about 20 per cent of the regulated river length that was assessed, the flow regimes were largely unmodified from an ecological perspective.

Stream habitat was modified from pre-European conditions in more than half of the river length that was assessed. Degradation of the habitat was considered to be largely because of changes in the sediment loads that alter channel morphology and loss of riparian vegetation. Scores for habitat were lowest in New South Wales, South Australia and Western Australia.

Nutrients and suspended sediment loads were higher than pre-European settlement conditions in more than 90 per cent of the river lengths assessed, and are substantially modified in at least one third of the river length that was assessed in every state and territory, except Tasmania.

Based on the 2001 Assessment of Murray-Darling Basin River Health Condition, the following observations were made:

- 10 per cent of river length was identified as severely impaired, having lost at least 50 per cent of the types of aquatic invertebrates expected to occur there;
- more than 95 per cent of the river length assessed had an environmental condition that was degraded and 30 per cent was substantially modified from the original condition;
- most reaches in the central and western part of the Basin were moderately modified;
- all groups of reaches in the Basin had disturbed catchments and modified water quality;
- many parts of the Basin were threatened by multiple stresses, principally land use changes, damaged riparian vegetation, poor water quality, increased bedload, and modified hydrology.

2. GOVERNANCE ASPECTS

2.1. WATER INSTITUTIONS

The Department of Sustainability, Environment, Water, Population and Communities and the following executive agencies and statutory authorities form the Australian government's Sustainability, Environment, Water, Population and Communities portfolio.

The National Water Commission is responsible for driving progress towards the sustainable management and use of Australia's water resources under the blueprint for water reform. Established under the National Water Commission Act 2004, the Commission advises COAG and the Australian government on national water issues and the progress of the National Water Initiative. Under the Water Act 2007, the Commission has a new, ongoing function to audit the effectiveness of implementation of the Murray-Darling Basin Plan and associated water resource plans. The Commission also has an assessment role for National Partnership Payments. This task is being undertaken under delegation from the COAG Reform Council.

The National Water Initiative was signed by all governments at the June 2004 Council of Australian

Governments (COAG) meeting, with the exception of Tasmania, which signed the Agreement on 3 June, 2005, and Western Australia, which signed the Agreement on 6 April, 2006.

2.2. WATER MANAGEMENT

Throughout Australia, water is managed in a variety of ways. Each Australian state and territory operates under its own set of institutional arrangements with regard to:

- water pricing and economic regulation;
- rural and regional water planning and management;
- metropolitan water planning and management;
- water markets;
- water supply and services;
- drinking water management;
- recycled water management;
- environmental health management.

2.3. WATER POLICY AND LEGAL FRAMEWORK

The key features of the Water Act 2007 are:

- the Act establishes the Murray-Darling Basin Authority (MDBA) with the functions and powers, including enforcement powers, needed to ensure that Basin water resources are managed in an integrated and sustainable way;
- the Act requires the MDBA to prepare the Basin Plan – a strategic plan for the integrated and sustainable management of water resources in the Murray-Darling Basin;
- the Act establishes a Commonwealth Environmental Water Holder to manage the Commonwealth's environmental water to protect and restore the environmental assets of the Murray-Darling Basin and outside the Basin where the Commonwealth owns water;
- the Act provides the Australian Competition and Consumer Commission (ACCC) with a key role in developing and enforcing water charge and water market rules along the lines agreed in the National Water Initiative;
- the Act gives the Bureau of Meteorology water information functions that are in addition to its existing functions under the Meteorology Act 1955.

In December 2008, the Water Amendment Act 2008 amended the Water Act 2007. The key features of the Water Amendment Act 2008 are:

- the functions of the Murray-Darling Basin Commission were transferred to the Murray-Darling Basin Authority; there is now a single body responsible for overseeing water resource planning in the Murray-Darling Basin;
- the role of the ACCC was strengthened by providing for the water charge rules and the water market rules to apply to all water service providers and transactions;
- the current powers of the ACCC were extended to determine or accredit determination arrangements for all regulated non-urban water charges;
- it enabled the Basin Plan to provide arrangements for meeting critical human water needs;

The Water Amendment Act 2008 was based on a combination of Commonwealth constitutional powers and a referral of certain powers from the Basin States to the Commonwealth; the Act passed through the Commonwealth parliament following the passage of referring legislation through the Basin states: Queensland, New South Wales, Victoria and South Australia.

As part of the government's collaborative approach to water management, the Water Amendment Act 2008 was achieved after negotiating two very important intergovernmental agreements:

- March 2008: the Memorandum of Understanding on Murray-Darling Basin Reform was signed by the Prime Minister and the Premiers of New South Wales, Victoria, South Australia and Queensland, and the Chief Minister of the Australian Capital Territory.
- July 2008: an Intergovernmental Agreement on Murray-Darling Basin Reform (PDF 233 KB) was signed by First Ministers, which built on the principles of the Memorandum of Understanding. In the Intergovernmental Agreement, Governments committed to a new culture and practice of Basin-wide management and planning, through new governance structures and partnerships.
- Regulations can be made to prescribe certain matters as provided for under the Water Act 2007. On 19 June, 2008 the Federal Executive Council approved the Water Regulations 2008, also referred to as the Principal Regulations. Any regulations made under the Act after the principal regulations will be Water Amendment Regulations.

3. RELIGIOUS AND CULTURAL ASPECTS

In the 21st century, religion in Australia remains dominated demographically by Christianity, with 64 per cent of the population claiming at least nominal adherence to the Christian faith as of 2007, although less than a quarter of those attend church weekly. In the 2006 census, 18.7 per cent of Australians declared 'no religion' (with a further 11.2 per cent failing to answer the question); the remaining population is a diverse group that includes fast-growing Islamic and Buddhist communities.

The Constitution of Australia prohibits the Commonwealth government from establishing a church or interfering with the freedom of religion; states are free under their own constitutions to interfere or establish a church as they see fit, although none ever has. Nevertheless, the relationship between the Commonwealth government and religion is much freer than in the United States, with governments working with religious organizations that provide education, health and other public services.

A further change in attitudes to water management is apparent in the growing interest in indigenous values associated with rivers and wetlands, the contribution of indigenous environmental knowledge and activity to water management, and the equitable participation of indigenous people in water resource institutions. Indigenous people constitute a significant sector of north Australian society, and have a large stake in water resource management arising from their distinct environmental philosophy, customary land and resource rights, long traditions of water resource management, and an extensive and growing land base.

Indigenous people have had negligible direct experience of participating in non-indigenous-initiated water management, and little is known about their attitudes to increased industrial water

consumption, water trading, or how market-based mechanisms will influence water consumption and use by indigenous communities. However, there are several lines of evidence that suggest that indigenous people are likely to adopt a more conservative and hence potentially environmentally sustainable approach to water management than has been previously adopted elsewhere in Australia.

A growing number of studies show that many indigenous groups have complex systems of rights to access and utilise wetland and riparian resources under indigenous law.
