1. PHYSICAL ASPECTS

1.1. WATER RESOURCES

1.1.1. WATER RESOURCES

Croatia is endowed with relatively abundant water resources and characterized by major rivers and the karst coastal area. Water resources differ in size and distribution in time and space. Water management includes a number of activities and measures aimed at maintaining, improving and ensuring the unity of the water regime in a specific area. The water regime is underpinned by essential water management principles and plans.

With a national territory of 87,609km², Croatia is at the meeting point of the Pannonian Plain, the Balkans and the Adriatic. The country straddles the border of two major catchment areas: the Danube Basin and the Adriatic Sea. Draining over 62 per cent of Croatia's mainland, the Danube Basin covers the northern and central inland section of the country and is home to 69 per cent of the population. Croatian territory accounts for 4.4 per cent of the entire Danube Basin.

The Croatian section is dominated by major rivers (and their tributaries), notably the Drava, the Sava and the Danube itself. Croatia has been a signatory to the Danube River Protection Convention since 1994.

1.1.2. WATER USE

Croatia contains large quantities of both surface water and groundwater resources, although they are unevenly distributed. Low-lying parts of the Danube Basin are dominated by arable areas, while the upland regions of north and central Croatia are forested. The Basin is particularly unevenly populated. The majority live in the larger towns (density is greatest in Zagreb and Osijek) while other areas, particularly mountainous ones, are very sparsely populated.

A major proportion of electricity generation comes from hydropower, with the Drava currently providing the largest capability. The most effective locations are already exploited; new sites could potentially cause significant environmental impacts. The Drava and the Danube are major routes for international transportation (80 per cent of goods shipped on inland waterways involve international trade) and the four-country Framework Agreement on the Sava Basin aims to further develop navigation. Discharging wastewater (both treated and untreated) into watercourses is common practice, but discharge direct into groundwater is prohibited. The majority of industrial facilities discharge into public sewerage systems; some of this discharge is then treated before release into watercourses. With regard to drinking water, 90 per cent of abstractions are from groundwater, with the remainder from rivers and reservoirs; there are few surface water intakes. An important measure for protecting drinking water aquifers is the adoption and enforcement of

sanitary protection zones, a challenging task at most abstraction sites.

Estimates indicate that 15 per cent of the mainland is at risk of flooding; however, the major part is protected to varying degrees. In the Sava Basin, due to the reduction in peak flows of flood waves in lowland flood storages, the middle basin plays a key role in protecting the Slavonian stretch and neighbouring countries. Measures based on lowland flood storages and expansion areas have enabled the preservation of environmentally favourable conditions on wide floodplains. In the Drava and Danube Basins, protection is based on embankments and wide foreshores.

1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Croatia's major environmental problems are: air pollution (from metallurgical plants) and the resulting acid rain, which damages forests; coastal pollution from industrial and domestic waste; landmine removal and reconstruction of infrastructure consequent to 1992-95 civil strife.

With regard to organic load, of the 28 per cent of wastewater that is treated, 43 per cent undergoes preliminary/primary treatment and 57 per cent secondary treatment. The most serious problems occur in small settlements (up to 2,000 inhabitants), where 40 per cent of the population live. The situation in settlements with more than 10,000 inhabitants is considered satisfactory in the main. Around 44 per cent of all settlements with built sewerage systems have wastewater treatment plants. Of 109 plants, 38 involve preliminary treatment, 24 primary, 46 secondary and one tertiary. Changing economic conditions have meant many industries have constructed their own plants for preliminary treatment. At the same time, connection rates for public sewerage systems with central municipal plants have not increased at the rate predicted. Major parts of many settlements remain without connection to central treatment plants.

With regard to agricultural pollution, and on the basis of processed data, the highest loads from diffuse sources are present in the Drava and Danube Basins and in the immediate Sava Basin.

2. GOVERNANCE ASPECTS

2.1. WATER INSTITUTIONS

Water management in Croatia is the responsibility of:

- the Ministry of Agriculture, Forestry and Water Management (as a state administration body) and Croatian Water (as a state agency);
- the Ministry of Regional Development, Forestry and Water Management;
- the Department for water policy and international projects;
- the Department for water management.

2.2. WATER MANAGEMENT

Water is a public resource which, because of its natural properties, cannot be anybody's property

and thus, pursuant to the Constitution of the Republic of Croatia, enjoys special protection.

The legal foundations of water management in Croatia are defined by the Water Act, the Water Management Financing Act and their bylaws, with individual provisions related to water found also in several other laws that regulate other legal areas.

The territory of Croatia is, for water management purposes, divided into four water basins and 34 catchment areas. The water basin comprises one or more catchment areas of major river watercourses, or parts thereof, constituting a natural hydrographical entity, whereas the catchment area comprises, within a water basin, one or more catchments of minor watercourses for which integrated water management is provided, with regard to interconnected problems, existing water systems and economic conditions.

The planning basis for water management in Croatia is the Water Management Master Plan of Croatia and the water management plans and schemes of the catchment areas. The Water Management Master Plan of Croatia is a long-term planning document that is systematically harmonized with changes occurring in the water system and socio-economic development, and is also mutually harmonized with the National Physical Planning Strategy, Environmental Protection Strategy, state-level forest management planning documents and the planning documents of inland navigation system development.

Under the new European scenario, the Water Framework Directive prescribes that management activities should aim to achieve the goals of the Directive within geographical areas or river basin districts (RBDs). These are based largely on surface water catchments, together with the boundaries of associated groundwater and coastal water bodies.

For each river basin district, a river basin planning process must be set up. The first milestone of this planning process (analysis, monitoring, objective-setting and consideration of measures to maintain or improve water status) is the initial river basin management plan (RBMP).

These RBMPs should be made available for information and consultation by the public. The river basin management plan should:

- record the current status of water bodies within the river basin district;
- set out the measures planned to meet the objectives;
- act as the main reporting mechanism to the Commission and the public.

The whole process of river basin management planning includes the preparation of programmes of measures at basin level for achieving the environmental objectives of the Water Framework Directive cost-effectively. Basic measures include control of pollution at source through the setting of emission limit values and environmental quality standards. The use of economic instruments, such as water pricing, is part of the basic measures. Here, in particular, the 'polluter pays' principle should be taken into account. The Directive aims to ensure that pricing policies improve the sustainable use of water resources.

The planning, implementation and evaluation of the programme of measures is an iterative process that will probably include the river basin management plan of the first (2009), second (2015) or further cycles (2021, 2027).

2.3. WATER POLICY AND LEGAL FRAMEWORK

The Water Management Strategy defines the legislative, organizational, financial, technical, scientific and IT aspects of water management activities in the present socio-economic circumstances of the accession process of Croatia to the European Union, as well as in the future circumstances of full membership.

The Strategy will be in force as long as the assumptions on the basis of which it was adopted hold true, taking into consideration the period of legal approximation lasting until the end of 2008, and two 15-year investment cycles closing at the end of 2038.

Analyses of the current status and developmental needs show that Croatia possesses sufficient quantities of water for its own needs, and that water resources, in terms of their quality and quantity, are not a restricting factor of economic development. However, due to the marked temporal and spatial unevenness of the water regime, efficient and environmentally friendly water management requires systematic investment in the development and regular maintenance of water management systems. Analyses also show that, due to partly non-repaired war damage, as well as to a long period of insufficient investment in the development and regular maintenance of protective systems, the safety of the population and assets in many potentially flood-exposed areas has been significantly reduced.

The basic aim of the Strategy is the establishment of an integrated and coordinated water regime on the national territory and on each of the four river basin districts, which includes the following:

- the provision of sufficient quantities of drinking water of good quality for the population;
- the provision of the required quantities of water of adequate quality for various economic purposes;
- the protection of people and assets against floods and other adverse effects of water;
- the preservation of the good status of water in order to protect aquatic and water-dependent ecosystems.

The strategic goal of protection against floods and other adverse effects of water is to bring the flood protection system on waters of first and second rank to the level of 87 per cent functionality by the end of 2023 and to 100 per cent functionality by the end of 2038. This goal will be achieved through the gradual execution of repair and reconstruction works, and through realization of developmental projects. The functional systems will undergo regular technical and economic maintenance.

The strategic goal of the development of the public water supply is to increase the percentage of population supplied with water from public water supply systems from the current 80 per cent to 85-90 per cent by the year 2023, which is in line with European standards. Likewise, the activities related to the establishment of sanitary water source protection zones and implementation of adequate protective measures, activities related to the improvement of drinking water quality in accordance with the EU Drinking Water Directive, and activities related to the repair of losses from water supply distribution networks are expected to intensify. In view of the problems relating to the existing status of water utility management, intensive work will be carried out on its

consolidation, i.e. on the establishment of distribution/service areas as technologically and economically sustainable units.

3. GEOPOLITICAL ASPECTS

Because of the geographical and hydrographical characteristics of Croatian national territory, international cooperation is one of the key factors in water management in Croatia. So far, Croatia has concluded bilateral agreements on cooperation in the field of water management with the neighbouring countries of Hungary, Slovenia and Bosnia-Herzegovina, while agreements with Serbia and Montenegro are under preparation.

At the multilateral level, Croatia has signed the Convention on the Protection of the Danube River, the Framework Agreement on the Sava River Basin, the Barcelona Convention for the Protection of the Mediterranean Sea against Pollution and the Helsinki Convention on the Protection and Use of Transboundary Watercourses and International Lakes.

The International Sava River Basin Commission (ISRBC) has been established for the purpose of the implementation of the Framework Agreement on the Sava River Basin (FASRB), namely the cooperation of the parties to the FASRB in order to realize the following goals:

- establishment of an international regime of navigation on the Sava river and its navigable tributaries, which includes the provision of conditions for safe navigation on the Sava and its tributaries, by:

- adopting plans for the marking, maintenance and development of navigable waterways;
- adopting the unified rules of navigation, taking into account specific conditions of certain parts of the navigable waterways;
- adopting the technical rules concerning inland navigation vessels and rules on obtaining boat master certificates;
- establishing the River Information Services;

- establishment of sustainable water management, which includes cooperation on the sustainable management of the Sava River Basin water resources, including integrated management of surface and groundwater resources, in a manner that would provide:

- water in sufficient quantity and of appropriate quality for the preservation, protection and improvement of aquatic eco-systems (including flora and fauna and eco-systems of natural ponds and wetlands);
- water in sufficient quantity and of appropriate quality for all kinds of use;
- protection against detrimental effects of water (flooding, excessive groundwater, erosion and ice hazards);
- resolution of conflicts of interest caused by different water uses;
- effective control of the water regime;

- implementation of measures to prevent or limit hazards such as floods, ice, droughts, and accidents involving substances hazardous to water, and to reduce or eliminate related adverse consequences.

The International Commission for the Protection of the Danube River (ICPDR) is an organization

consisting of 14 member states (Germany, Austria, the Czech Republic, Slovakia, Slovenia, Hungary, Croatia, Bosnia and Herzegovina, Serbia, Bulgaria, Romania, Moldova, Montenegro and Ukraine) and the European Union. The commission, established in 1998, deals with the whole Danube River Basin, which includes tributaries and groundwater resources. Its goal is to implement the Danube River Protection Convention by promoting and coordinating sustainable and equitable water management, including conservation, improvement and rational use of waters.

To achieve good water status in the water bodies of the Danube region by 2015 (and beyond) and to ensure a sufficient supply of clean water for future generations, the Contracting Parties to the DRPC nominated the ICPDR as the co-ordination body for the development of a comprehensive management plan for the entire Danube River Basin using the principles of the EU Water Framework Directive.
