## Country Aspects

### 1. PHYSICAL ASPECTS

#### 1.1. WATER RESOURCES

##### 1.1.1. WATER RESOURCES

Lake Balaton is the largest and warmest freshwater lake of Central Europe. The two most important rivers, the Danube (its length in Hungary is 417km) and the Tisza (597km), cross the country from north to south. Flooding can endanger 52 per cent of the country.

The renewable water resources total 120 billion m<sup>3</sup> annually, which is mainly provided by the Danube river (the amount of inflowing water per capita in Hungary is the highest in the world). About three quarters of the country's groundwater resources (shallow groundwater and bank-filtered and karstic water) is vulnerable. Half of the population is supplied with drinking water from bank-filtered wells, located along the Danube and other rivers of excellent quality. The country is rich in thermal waters.

##### 1.1.2. WATER USE

The vast majority of Hungary's waterworks are reliant on groundwater: more than 90 per cent of the population is supplied in this way. Water utilities supply 560 million m<sup>3</sup> of drinking water per year and a further 240 million m<sup>3</sup> of water for other public uses. Annual industrial and agricultural abstraction accounts for almost 5,000 million m<sup>3</sup> and 680 million m<sup>3</sup> respectively. Power generation accounts for 95.48 per cent of industrial use; 68 per cent of agricultural use is for fishponds, and 27 per cent for irrigation.

Major rivers are important for transportation, and Hungary contains 1600km of navigable waterways. The Danube and Tisza are key international routes, while the Dráva is used for internal transport. Cargo transport is very small (currently around 8-10 per cent on the Danube and only 1-2 per cent on the Tisza) and potential is limited by the lack of a connection between the two rivers. The water regime is highly dependent on the flow regime, which has a major impact on the efficiency of shipping transport. Hungary's rivers also play a vital role in disposing of effluent, being the major recipients of both municipal and industrial wastewater. There is little potential for hydroelectric power (around 1 per cent of energy production is generated by hydropower).

As 21,712km<sup>2</sup> of Hungary is below river flood level, flood control is a key consideration. Crucially, this area includes 10,000m<sup>2</sup> arable land, 32 per cent of the rail network, 15 per cent of roads and more than 2,000 industrial plants. The highest flood discharge in the Danube is 20 times low flow; flooding on the major rivers can last several months. In smaller rivers, e.g. the Körös system, the ratio is several hundred to one and floods can develop in a few hours. Devastating, fast-rising ice-jam floods are especially dangerous. Flood control over past centuries has resulted in the

construction of 4,181km of defences (mainly earthen embankments). Ten emergency lowland flood reservoirs (with a total volume of 360 million m<sup>3</sup>) provide protection for 97 per cent of the floodplain area.

#### 1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

The upgrading of Hungary's standards in waste management, energy efficiency, and air, soil, and water pollution to meet EU requirements will require large investments.

Of 876 natural and 150 artificial water bodies identified in Hungary, 579 freshwater surface bodies have been classified as being "at risk" from organic, nutrient or priority hazardous substances (according to EU Water Framework Directive definitions).

Approximately 70 per cent of artificial lakes (mainly fishponds) are "at risk" from organic and nutrient loads. Organic and nutrient loads from point/diffuse sources are as follows (in 1,000 t/year): total nitrogen 24.8/20.0; total phosphorus 3.9/3.0; BOD<sub>5</sub> (Biochemical Oxygen Demand) 60.0/3.2; COD (Chemical Oxygen Demand) 12.3/20.5. Point source load is mainly from urban discharges (80-95 per cent, depending on pollutant).

None of the 108 groundwater bodies identified is considered to be "at risk" due to human intervention, but 46 sites are listed as "possibly at risk" (mostly from nitrate pollution from diffuse sources). Pollution has made phreatic groundwater near the surface unfit for drinking water.

349 water bodies have been identified as "at risk" and 234 "possibly at risk" from hydro-morphological alterations. These represent 42 per cent and 25 per cent of the total length of Hungarian water bodies respectively. In the case of lakes, 47 water bodies are "possibly at risk", including Lake Balaton.

### 2. GOVERNANCE ASPECTS

#### 2.1. WATER INSTITUTIONS

The government agency primarily responsible for policy with regard to the protection of freshwater resources is the Ministry for Environment and Water.

The Ministry of Transport, Communication and Water Management is responsible for inundation control, river and lake regulation, land drainage, water resources management, waterworks water supply, wastewater disposal and bathing services.

The Ministry of the Environment and Regional Policy is responsible for regulation and supervision of pollution control with regard to surface and subsurface waters.

The Ministry of the Interior is responsible for community drainage, water utility developments and labelled and special support to self-governments.

The Ministry of Industry, Trade and Tourism is responsible for industrial water uses, wastewater disposal and water power development.

The Ministry of Agriculture is responsible for water management, farmland drainage and reclamation.

The only specialized research institute in the water management sector is the Water Resources Research Center PLC (VITUKI).

### 2.2. WATER MANAGEMENT

The National Environmental Programme includes substantial provisions and measures for the conservation and management of surface and subsurface water resources. Some of the key targets and approved policy directions are: regulation development to encourage sustainable and economical water use; improvement of water quality for the main watercourses/waterbodies (Danube and Tisza rivers, Lake Balaton); gradual increase (to a level of 65 per cent) of the number of settlements with sewers; biological treatment of wastewater from sewers; nitrate and phosphorous load reductions for highly protected and sensitive waters.

A governmental programme – the New Vásárhelyi Plan – was started in 2004 for the enhancement of flood safety and related regional and rural development in the Tisza Valley. The Plan comprises a complex programme which covers the creation of a higher level of flood safety, the improvement of the living standards of the rural and urban population of the region, the formulation and introduction of new types of agro-ecological land use in the area of the emergency flood retention reservoirs, and the modernization of infrastructure in the settlements along the River Tisza.

On the basis of European Union guidelines, wastewater drainage and cleaning should be resolved for all settlements of over 2,000 inhabitants by 2015. The government has passed a programme to improve water quality management. The objective of the programme is to develop wastewater treatment and drainage systems and improve technical monitoring systems to meet EU standards.

The principal implementation problems of the programme resulted from the transitional state of legislation, difficulties in collaboration between various governmental agencies and local/regional authorities, and the limited availability of financial resources.

By 2003 the Hungarian legal background regarding water quality protection had become fully harmonized with the EU regulation, including the appropriate institutional setup. In 2004, further refinement of the relevant laws and decrees continued, which was necessary for two reasons:

- i) adaptation of the Water Framework Directive (2000/60/EEC) and
- ii) improvement and simplification of the relevant decrees on the basis of experience gained during the initial phase of implementation.

Preparation of the pollution reduction programmes (national and dischargers') has also begun, in compliance with the relevant EU directive (76/464/EEC). The extension of sanitation facilities is being implemented, partly with financial assistance from ISPA, the Cohesion and Structural Fund of the EU. As a result of the integrated programmes and measures, the quality of Hungarian surface water bodies shows permanently improving tendencies, as reported by the country-wide monitoring network.

### 2.3. WATER POLICY AND LEGAL FRAMEWORK

The basic regulatory framework consists of the Water Act of 1995 and the legal instruments regarding environmental impact assessments. In addition, there are important general provisions on freshwater resources under the Act on Environmental Protection (1995).

The most important legislation in Europe for the protection of our waters is the Water Framework Directive (WFD). This sets up a new legislative approach, establishing very ambitious objectives for the quality and protection of our waters, and relies on a river basin approach for water management.

There are four other pieces of EU water legislation that will remain in place with the WFD: the Urban Waste Water Treatment Directive, the Bathing Water Directive, the Nitrates Directive, and the Drinking Water Directive.

### 3. GEOPOLITICAL ASPECTS

The International Commission for the Protection of the Danube River (ICPDR) is an organization consisting of 14 member states (Germany, Austria, the Czech Republic, Slovakia, Slovenia, Hungary, Croatia, Bosnia and Herzegovina, Serbia, Bulgaria, Romania, Moldova, Montenegro and Ukraine) and the European Union. The Commission, established in 1998, deals with the whole Danube river basin, which includes tributaries and groundwater resources. Its goal is to implement the Danube River Protection Convention by promoting and coordinating sustainable and equitable water management, including conservation, improvement and rational use of waters.

To achieve good water status in the water bodies of the Danube region by 2015 (and beyond) and to ensure a sufficient supply of clean water for future generations, the Contracting Parties to the DRPC nominated the ICPDR as the coordination body for the development of a comprehensive management plan for the entire Danube River Basin using the principles of the EU Water Framework Directive.
