## Country Aspects

### 1. PHYSICAL ASPECTS

#### 1.1. WATER RESOURCES

##### 1.1.1. WATER RESOURCES

Poland has mean annual water resources per capita of approximately 1,600m<sup>3</sup>, almost three times less than the mean value for Europe. In addition, the available resources are subject to great year-to-year variability. Devastating floods and local water scarcities are frequent.

The longest rivers are: the Vistula (Polish: Wisła), 1,047km long; the Oder (Polish: Odra) which forms part of Poland's western border, 854km long; its tributary the Warta, 808km long; and the Bug, a tributary of the Vistula, 772km long. The Vistula and the Oder flow into the Baltic Sea, as do numerous smaller rivers in Pomerania.

The Łyna and the Angrapa flow by way of the Pregolya to the Baltic, and the Czarna Hańcza flows into the Baltic through the Neman. While the great majority of Poland's rivers drain into the Baltic Sea, Poland's Beskids are the source of some of the upper tributaries of the Orava, which flows via the Váh and the Danube to the Black Sea. The eastern Beskids are also the source of some streams that drain through the Dniester to the Black Sea.

Poland's rivers have been used since early times for navigation. The Vikings, for example, traveled up the Vistula and the Oder in their longships. In the Middle Ages and in early modern times, when the Polish-Lithuanian Commonwealth was the breadbasket of Europe, the shipment of grain and other agricultural products down the Vistula toward Gdańsk and onward to western Europe took on great importance.

With almost ten thousand closed bodies of water covering more than 10,000m<sup>2</sup> each, Poland has one of the highest numbers of lakes in the world. In Europe, only Finland has a greater density of lakes. The largest lakes, covering more than 100km<sup>2</sup>, are Lake Śniardwy and Lake Mamry in Masuria, and Lake Łebsko and Lake Drawsko in Pomerania.

In addition to the lake districts in the north (in Masuria, Pomerania, Kashubia, Lubuskie, and Greater Poland), there is also a large number of mountain lakes in the Tatras, of which the Morskie Oko is the largest in area. The lake with the greatest depth – of more than 100m – is Lake Hańcza in the Wigry Lake District, east of Masuria in Podlaskie Voivodeship.

Among the first lakes whose shores were settled are those in the Greater Polish Lake District. The stilt house settlement of Biskupin, occupied by more than one thousand residents, was founded before the seventh century BC by people of the Lusatian culture.

##### 1.1.2. WATER USE

Water withdrawals in Poland total around 16.2 km<sup>3</sup>/year. Water use by sector is:

- for agricultural use, 8 per cent;
- for domestic use, 13 per cent;
- for industrial use, 79 per cent.

#### 1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

Water quality management is one of the key issues, creating problems for people's livelihoods and the environment.

Water and air pollution affect the entire country, however. A 1990 report found that 65 per cent of Poland's river water was so contaminated that it corroded equipment when used in industry. After absorbing contaminants from the many cities on its banks, the Vistula river was a major polluter of the Baltic Sea. River water could not be used for irrigation. In 1990, about half of Poland's lakes had been damaged by acid rain, and 95 per cent of the country's river water was considered undrinkable. Because Polish forests are dominated by conifers, which are especially vulnerable to acid rain, nearly two thirds of forest land had sustained some damage from air pollution by 1990. In 1989, Polish experts estimated total economic losses from environmental damage at over US\$3.4 billion, including soil erosion, damage to resources and equipment from air and water pollution, and public health costs.

The situation has improved since 1989 due to a decline in heavy industry and increased environmental concern on the part of post-Communist governments. Air pollution nonetheless remains serious because of sulphur dioxide emissions from coal-fired power plants, and the resulting acid rain has caused forest damage; water pollution from industrial and municipal sources is also a problem, as is disposal of hazardous wastes. Pollution levels should continue to decrease as industrial establishments bring their facilities up to EU standards, but at a substantial cost to business and the government.

### 2. GOVERNANCE ASPECTS

#### 2.1. WATER INSTITUTIONS

The Ministry of the Environment, Department of Water Resources is the agency responsible for coordinating water resource management and development. Regional and local coordinating structures for the implementation of water resources management strategy and for the enforcement of water law and water quality have also been established.

Information on water management is collected by:

- the Central Office of Statistics: issues information of a national range on environmental protection, including water protection and water management, published as statistical information and annual reports;
- the Inspectorate for Environmental Protection: co-ordinates and conducts the state

environmental monitoring system, including water quality sub-systems, and publishes periodical reports and publications;

- the Institute of Meteorology and Water Management: conducts hydrological monitoring and water resources registers, publishing data in monthly and annual bulletins distributed throughout the country.

The networking of documentation systems is promoted by the AQUADOC System, which is supported by the French International Office for Water and implemented by the Institute of Meteorology and Water Management in Warsaw.

### 2.2. WATER MANAGEMENT

The development of a detailed sectoral programme – i.e. a Water Management Strategy – is currently the subject of consultation with sectoral ministries. Due to the unevenness in the water supply (98 per cent and 97 per cent of the urban population are served with water and sewerage systems respectively, compared with 80.4 per cent and 73.5 per cent respectively for the rural population), since the beginning of the 1990s a programme of construction for rural water supply and wastewater treatment systems has been implemented aggressively, and its achievements have been considerable.

This is part of an integrated governmental programme entitled Development of Rural Areas, which also covers sanitation in villages and health protection in rural areas. A programme of construction of municipal wastewater treatment plants is being continued as one of the priorities of the State Ecological Policy.

Industry is responsible for major water quality problems in Poland. The negative role of industry is, however, gradually being decreased thanks to a special programme directed at the 80 major national polluters. This programme includes specific monitoring and inspection sub-programmes as well as specific economic instruments to encourage industries to undertake necessary measures to reduce water consumption and to limit pollutant concentration and volumes of wastewater discharge.

Up until 1990, water was a resource that was freely accessible or available for a token fee. The implementation of more realistic operational tariffs and fees since the early nineties has resulted in considerable rationalization and a decrease in water consumption, especially for commercial purposes. An outline for a new system of fees has been drafted, incorporating the ‘polluter pays’ principle to a higher degree, encouraging better environmental behaviour from users and increasing the funds coming from environmental fees, which are allocated mainly to finance the protection of water resources. Increase in capital outlays and better enforcement of legal requirements since 1990 has resulted in a considerable decrease in the load of pollutants discharged into surface waters and consequently in an improvement in their quality. The provision of water supply for inhabitants and economic sectors is one of the major tasks of local self-governments. The private sector in Poland is a recipient rather than a creator of water resources management policy. The investment role of this sector, which generates over 60 per cent of GDP, is not significant. Industry is, however, the third major user of fresh water resources (after

agriculture and municipalities).

The new Water Law Act, aimed at increasing social participation (including representatives of industries) in creating and implementing water management policies at the basin level are being prepared. There are also measures in place to promote the recycling of water and biological treatment. The major constraints faced in the area of water management in Poland are: a lack of adequate financial resources; restructuring and changes in ownership of economic enterprises and changes in the ownership structure of waters and lands; and low levels of awareness and discipline among water users despite extended educational programmes and economic instruments.

### 2.3. WATER POLICY AND LEGAL FRAMEWORK

In general, principles of sustainable water management and protection of water resources are dealt with in the National Environmental Policy adopted in 1991, which aimed to improve quality and rationalize consumption of water resources, and the Executive Programme of this Policy until the year 2000, adopted in 1995.

Poland’s priorities for fresh water are: ensuring healthy and safe water for drinking and municipal use; limiting industrial water use; protecting underground waters against pollution; protecting waters susceptible to eutrophication; protecting lakes, inland water reservoirs, estuaries and Baltic water bays; protecting the open waters of the Baltic Sea against pollution, including from the point of view of their recreational use; limiting the impact of salt water from mining on the purity of water; meeting the commitments resulting from the international conventions signed by Poland; and increasing reservoir retention of surface waters and the use of water for energy production.

In order to prevent pollution and establish quality and health standards, a number of legal instruments have been developed. A procedure of consultation on governmental documents exists and includes the circulation of documents to interested institutions and non-governmental organizations. Mechanisms for the resolution of conflicts also exist at different levels. Institutional and legal conditions have been created to allow the participation of public and non-governmental organizations in the protection and management of regular waters.

Poland is presently preparing a new executive decrees concerning water conservation that will harmonize with European Union (EU) regulations. The implementation of the Water Framework Directive (2000/60/EC) in compliance with new Water Law Act is currently the main task of the State Water Board and regional water boards. All changes introduced during the law harmonization process will be in line with the basic principles of water management – the river basin principle, the public participation principle, the administrative principle (with the statutory control and supervision of State), the market principle, and the ‘polluter pays’ principle.

### 3. GEOPOLITICAL ASPECTS

Poland is a signatory to the Convention on the Protection of the Marine Environment of the Baltic Sea (Helsinki 1974, Helsinki 1992), the Convention on the Protection and Use of Transboundary Watercourses and International Lakes, and the Agreement Between the Government of the
