Country Aspects

1. PHYSICAL ASPECTS

1.1. WATER RESOURCES

1.1.1. WATER RESOURCES

A significant part of Slovakia's surface water flows in from the neighbouring states, though the usability of this fund is limited. It has a long-term average annual precipitation of 824mm/yr. The long-term average of annual renewable water resources is stated in 50,100 million m³/yr of which 25 per cent of them are considered as internal water resources (12,600 million m³) and 75 per cent are considered as external water resources (37,500 million m³). By the year 2009 the total dam (reservoir) capacity is stated as 1,760 million m³.

Slovakia has two river basin districts (RBDs), out of which both are international sharing watersheds, with Austria to the west, Poland and Czech Republic to the north and Hungary to the south. The two basins are the Danube RBD and the Vistula RBD. The consultation on the draft river basin management plans took place between 23 January 2009 and 22 July 2009. The final implementation of those river basin management plans is still pending.

1.1.2. WATER USE

Water withdrawal in the country by the year 2007 was estimated at 688 million m³. Around 48 per cent of the total resources abstracted come from surface water bodies, and around 52 per cent come from groundwater bodies.

This water abstraction can be itemised by user sector. By the year 2007, it was estimated that the water dedicated to agriculture reached 22 million m³. These resources were used in 390,900m³ of the total area equipped for irrigation of 1,720,000m³ in the whole country (2007), which represents a significant percentage of the area dedicated to cultivation (12.3 per cent) For urban purposes the water abstraction was stated as 320 million m³ and for industrial uses the value was stated as 346 million m³.

1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

The last two decades have been characterised by a reduction in the application of agrochemicals in the production process, which has had positive impacts on the environment. During the nine years between 1990 and 2009, industrial fertilizer consumption decreased by 59 per cent, and pesticide consumption dropped by 27 per cent. Numbers of livestock also sharply dropped; cattle by 69 per cent and pigs by 70 per cent. Compared to 1991, organic farming on the agricultural land area increased from 0.59 per cent to 7.6 per cent.

One of the main environmental challenges for Slovakia in the short-term is complying with the

wastewater discharge and biochemical sewage treatment for settlements of more than 2,000 people by the year 2015.

The groundwater quality is, in the long-term, favourable in Slovakia. In 2009, groundwater pollution observed in objects situated near strong pollution sources was, in most cases, caused by over-limit concentrations of Fe, Mn, NH₄, NO₃⁻, Cl⁻, and SO₄²⁻. Sporadically, excessive concentrations of trace elements Al, As, Pb, Hg and Sb also occur in the groundwater.

Good chemical status has been classified in 82.7 per cent of groundwater bodies, representing 76.4 per cent of the total area of groundwater bodies in Slovakia. The major pollutants are sulphates, chlorides, nitrates, ammonia, pesticides, trichloroethene, and tetrachloroethylene.

Anthropogenic activities realised in river basins may result in a deterioration of surface water quality with detrimental effects on ecosystems.

On the basis of the preliminary evaluation of the monitoring results of surface water status performed in 2007, it is possible to state that 1.139 water bodies out of the total number of 1.761 water bodies (c.65 per cent) have been classified as having high or good ecological status (or potential). The remaining water bodies have been classified as having worse than good status.

The chemical status of surface water bodies has been evaluated on the basis of monitoring results at 67 sampling sites covering 46 surface water bodies in 2007. Sampling sites were situated at the localities of their assumed source and at the borders with neighbouring countries. Twenty-four surface water bodies out of the total number of 46 surface water bodies have been evaluated as failing to achieve good chemical status and 22 surface water bodies have been classified into the good chemical status class.

In vulnerable zones, nitrates were observed in the network of 560 groundwater objects. During 2004-07, there were observations that the nitrate limit value (50 mg/L) was exceeded in 49 objects, i.e. 8.75 per cent of objects.

In the case of surface waters in sensitive areas, including vulnerable zones, nitrates were observed in 224 surface water sampling sites and chlorophyll a, as an indicator of trophic status, was observed in 49 sampling sites. During 2004-07, the annual average nitrate concentration in the highest number of sampling sites (74 per cent) ranged from 2-9.99 mg/L. Exceedances over 50 mg/L were observed in none of the sampling sites. As for chlorophyll a, the results showed that the highest numbers of sampling sites were classified into mesotrophic status (46.9 per cent), eutrophic status was observed in 18.36 per cent of sites. There were no sampling sites classified as having hypertrophic status.

From 1998 to 2009, the volume of discharged wastewater decreased by 54.4 per cent in Slovakia. In 2009, the total volume of discharged wastewater into watercourses was 620.358.090m³. The percentage of discharged treated wastewater of the total volume of wastewater discharged into watercourses in 2009 was 94.67 per cent.

2. GOVERNANCE ASPECTS

2.1. WATER INSTITUTIONS

Central government consists of 14 departments. Many environmental policy functions are managed within the Department of Environment. Department of Economy, Department of Agriculture, The Department of Health and Department of Transport, Post and Telecommunications partly participate in environmental legislation processes and enforcement. Regional environmental authorities, district environmental authorities and municipalities have responsibility for regional, district and local development, as well as the enforcement of environmental regulations. The major executive body of environmental policy in the Slovak Republic is the Slovak Inspectorate of the Environment. The Slovak Environmental Agency, the State Nature Conservancy of the SR, research institutes and other organisations are statutory bodies responsible for protecting the environment.

2.2. WATER MANAGEMENT

Water quality management became a core environmental issue during the EU accession transition period in Slovakia. In addition, currently the main policy objectives are to use freshwaters in a sustainable manner, protecting drinking water supply and freshwater ecosystems and preventing further deterioration of water sources.

The most important documents reflecting the response on freshwater pressures and impacts are river basin management plans, programmes of measures and monitoring programmes implemented in line with requirements of the Water Framework Directive. They will be published for the first planning cycle in 2009 and will be legally binding. Other examples of the country's response are the adoption of the Code of Good Agricultural Practice, the protection of waters against pollution caused by nitrates from agricultural sources, a programme to decrease pollution caused by certain dangerous substances, the plan for the public water supply and sewerage system development, etc.

Some of the main issues concerning environmental objectives of surface water and groundwater status, as well as wastewater in Slovakia are:

- To ensure the connection to the public sewerage network of all inhabitants living in agglomerations with more than 10,000 inhabitants by the end of 2010;
- To ensure the discharge and full biological treatment of wastewater in settlements of more than 2,000 people by the end of 2015;
- To implement measures to reduce pollution by priority substances gradually and to cease or phase out emissions, discharges and losses of priority hazardous substances by December 2020.

The water management plan (river basin management plan) of Slovakia was approved by the Government on February 10, 2010, and is available on the Ministry of Environment of the Slovak Republic website.

2.3. WATER POLICY AND LEGAL FRAMEWORK

The main Directives and related legislation at European level, regarding the domain of water resources management, are:

- Directive 80/68/EEC of 17 December, 1979 on the protection of groundwater against pollution caused by certain dangerous substances;
- Directive 82/176/EEC of 22 March, 1982 on limit values and quality objectives for mercury discharges by the chlor-alkali electrolysis industry; covers inland surface water, territorial waters and internal coastal waters;
- Directive 83/513/EEC of 26 September, 1983 on limit values and quality objectives for cadmium discharges; sets limit values and quality objectives for cadmium discharges in the aquatic environment;
- Directive 84/156/EEC of 8 March, 1984 on limit values and quality objectives for mercury discharges by sectors other than the chlor-alkali electrolysis industry; sets limit values and quality objectives for mercury discharges in sectors other than the chlor-alkali electrolysis industry;
- Directive 84/491/EEC of 9 October, 1984 on limit values and quality objectives for discharges of hexachlorocyclohexane;
- Directive 91/271/EEC of 21 May, 1991 concerning urban waste water treatment;
- Directive 91/676/EEC of 12 December, 1991 concerning the protection of waters against pollution caused by nitrates from agricultural sources (known as the Nitrates Directive);
- Directive 98/83/EC of 3 November, 1998 on the quality of water;
- Directive 2000/60/EC of the European Parliament and of the Council establishing a framework for the Community action in the field of water policy;
- Regulation (EC) No 648/2004 of the European Parliament and of the Council of 31 March, 2004 on detergents;
- Decision 2006/507/EC of 14 October, 2004 concerning the conclusion, on behalf of the European Community, of the Stockholm Convention on Persistent Organic Pollutants (POPs);
- Directive 2006/7/EC of the European Parliament and of the Council of 15 February, 2006 concerning the management of bathing water quality and repealing Directive 76/160/EEC (with effect from 31 December, 2014);
- Directive 2006/44/EC of 6 September, 2006 on the quality of fresh waters needing protection or improvement in order to support fish life (this Directive will be repealed by the Framework Directive on water as of the end of 2013);
- Directive 2006/11/EC of the European Parliament and of the Council of 15 February, 2006 on pollution caused by certain dangerous substances discharged into the aquatic environment of the Community the European Union (this Directive will be repealed by the Framework Directive on water as of the end of 2013);
- Proposal for a European Parliament and Council Directive of 22 September, 2006 setting out a framework for soil protection and amending Council Directive 2004/35/EC [COM (2006) 231 final – not published in the Official Journal];

- Directive 2006/118/EC of the European Parliament and of the Council of 12 December, 2006 on the protection of groundwater against pollution and deterioration;
- Directive 2007/2/EC of the European Parliament and of the Council of 14 March, 2007 establishing an Infrastructure for Spatial Information in the European Community (INSPIRE);
- Commission Communication of 18 July, 2007: "Addressing the challenge of water scarcity and droughts in the European Union" [COM (2007) 414 final – not published in the Official Journal];
- Directive 2007/60/EC of the European Parliament and of the Council of 23 October, 2007 on the assessment and management of flood risks; aims to manage and reduce the risk of floods, particularly along rivers and in coastal areas;
- Directive 2008/1/EC of the European Parliament and of the Council of 15 January 2008 concerning integrated pollution prevention and control (the IPPC Directive);
- Directive 2009/28/EC on the promotion of the use of energy from renewable sources and amending and subsequently repealing Directives 2001/77/EC and 2003/30/EC.

As a member state of the European Union, Slovakia has to implement this legislation in its own legal framework, defining specific laws for the implementation of the different directives and the common legislative principles. This is a responsibility of the Ministry of Environment of the Slovakia. Further information on this local legislation can be found on its web page.

3. GEOPOLITICAL ASPECTS

Slovakia is largely located in the mountainous territory of the north-western Carpathian arch. The central part is formed by the Tatra Mountains. The outer part is shaped by Flysch Mountains. Pannonian lowlands extend into the southwest of Slovakia. Limestone areas hold many caves. Due to the geological structure of the territory, there are many mineral springs and thermal waters in Slovakia. The climate can be considered as temperate. The geographic position of Slovakia in the centre of Europe and allows for a rich diversity of flora and fauna.

In 2009, Slovakia had 5.4 million inhabitants. Most of the population is concentrated in the lowlands and valleys. Extensive land use and settlement has had a considerable impact on the original landscape structure and ecosystem composition. Rural settlements contain numerous elements of traditional architecture. Mountain depressions and valley corridors shelter medieval castles and ruins.

As stated above, Slovakia has experienced a relatively high rate of land-use change since 1990. The main changes observed in Slovakia have been migration of the rural population to urban areas, which determined land use changes, a significant increment of new forests and an increase in built-up areas. Urban sprawl took place in the surroundings of large cities, due to the development of new houses, commercial and industrial sites, and at the expense of arable land. Such changes cause losses of soil as a non-renewable and food source, biodiversity decrease and decrease of carbon sinks.

Slovakia formed part of Czechoslovakia from 1918 and became an independent state on 1 January 1993 after the dissolution of its federation with the Czech Republic. Intensified agriculture and the heavy industry, especially the production of weapons and other military equipment, had been

based largely in Slovakia. The Slovak economy had been transformed from a centrally planned economy to a market driven economy. In the last years, the Slovak economy had been characterised by a sustained high economic growth during the last decade.

Slovakian industry was characterised by a heavy industry and high energy and resource demands. Fundamental changes in Slovakian industry were applied in the 1990s. Due to foreign direct investment, modern technologies were introduced. In 2009, the greatest share of GDP generation at the level of 35.3 per cent comes from industry, and Slovakia has become the leading car manufacturer (per capita) in Europe. Compared to other EU countries, the energy demand from industry is very high (traditionally a high proportion of the heavy industry). In 2008, industry's share of total energy consumption in Slovakia reached 40.4 per cent (the EU-27 average was 27.2 per cent)

Since 1990, structure of primary energy source consumption (PES) shifted toward non-fossil PES and natural gas. During 1995 to 2008, final energy consumption showed a reduction of almost 20 per cent as a result of the drop in economic activities. Nuclear power plants provide more than a half of electricity production in Slovakia, whilst thermal power plants represent approximately a 30 per cent. In the period between 1993 and 2008, the use of energy from renewable energy sources in Slovakia increased by 50 per cent.
