1. PHYSICAL ASPECTS

1.1. WATER RESOURCES

1.1.1. WATER RESOURCES

Average annual precipitation in Switzerland is 1,537mm. Average annual renewable water resources stand at 535 million km³. 40,400 million m³/yr of this comes from internal water resources and 131 million km³ from external water resources. In 2009 the country's total dam (reservoir) capacity was 33.45 million km³.

Switzerland has eight rivers: the Rhine, the Aar, the Rhône, the Reuss, the Linth/Limmat, the Saane, the Thur and the Inn. The Rhine is one of Europe's longest (1,320km) and most important rivers, with an average discharge of more than 2,000m³ per second.

Switzerland holds 6 per cent of Europe's fresh water. The Rhine, Rhone and Inn all have their source in the country, although they flow into three seas: the North Sea, the Mediterranean and the Black Sea.

The Rhine Falls, a few kilometres downstream of Schaffhausen, are the largest in Europe, at 150m wide and 23m high.

Switzerland also has over 1,500 lakes. The two largest, Lake Geneva and Lake Constance, lie on the country's borders – Geneva with France and Constance with Germany and Austria. Lake Geneva, which lies on the Rhone, is the largest freshwater lake in central Europe.

The biggest lake lying wholly within Switzerland is Lake Neuchâtel, with an area of 218.4km². Probably the best known lake is Lake Lucerne in Central Switzerland (113.7km²).

1.1.2. WATER USE

Water is used in many ways. Intensive farming practices and the demands of society at large for water, sanitation and recreation impair water quality and heighten pressures on the aquatic environment. Climate change is altering the temporal and spatial availability of water (FOEN, 2011). Some 80 per cent of water used for drinking and for industry in Switzerland comes from groundwater.

In 2000, total freshwater withdrawal was around 26.14 million km³. 0.05km³ of all water withdrawn was used for agriculture, 1.004km³ for municipal purposes and 1.503km³ for industry. Per capita water consumption in Switzerland is 3.603 km³.

1.2. WATER QUALITY, ECOSYSTEMS AND HUMAN HEALTH

The quality of Swiss surface water has improved significantly, with decreasing nitrate and phosphorus levels, as a result of excellent wastewater treatment infrastructure and a ban on

phosphorus in detergents. However, discharge of micropollutants via wastewater treatment plants and other sources remains a challenge for water protection.

The habitat quality of a surface water body depends not only on the quality of the water, but also on its morphology, the water flow and bed-load regime, and the water temperature. Construction work has considerably altered approximately 10,000km of Switzerland's 65,000km water network (FOEN, 2009). In many rivers and streams, the volume of residual water remaining after abstraction is not sufficient to maintain their diverse functions. In Alpine rivers downstream from hydropower plants, hydropeaking (surge/low-flow dynamics) impairs natural habitat. Stream control measures, gravel extraction and hydropower facilities alter the bed-load regime. This results in more uniform and structurally impoverished habitats, with declining biodiversity. The waterbeds are sealed, particularly near weirs at run-of-river hydropower facilities, impairing drainage and diminishing groundwater recharge.

The average temperature of the Rhine at Basel has risen by more than 2°C in the last 50 years. Climate change and discharge of heated water (for example, from cooling plants, and showers and washing machines via wastewater treatment plants) have contributed to this. Many aquatic organisms are sensitive to this temperature rise.

Overall quality of groundwater is good, according to National Groundwater Monitoring results. There are some problems in areas of intensive agriculture and in built-up areas, where high nitrate concentrations, plant protection products, pharmaceutical products and traces of chemicals from industrial processes are found. Human health is not at risk from pollutant levels, based on current knowledge. However, pollutants, especially where they exceed national limits, are a warning sign and need to be taken seriously.

Switzerland, as part of the Alpine region, serves as a "water tower" with abundant water resources. Only a fraction of these are abstracted. This is reflected in a low water exploitation index.

Switzerland generates 1.5 billion m³ of wastewater annually. 1.45 billion m³ of this is municipal wastewater. The rest is industrial and hospital effluent.

The impacts of pollution on surface and groundwater need to be considered both in urban and built-up areas (where consequences can include wet-weather discharges and pollutant inputs from heavily used traffic routes) and in agricultural areas (where impacts can include discharge of fertilizers and pesticides via seepage, leaching, erosion, runoff and deposition) (EEA, 2011).

2. GOVERNANCE ASPECTS

2.1. WATER INSTITUTIONS

The Federal Office for the Environment (FOEN) is the federal government's centre of environmental expertise. It is part of the Federal Department of the Environment, Transport, Energy and Communication (DETEC). FOEN monitors water levels and water quality in rivers, lakes

and groundwater bodies. It is legally responsible for protecting water from pollution and overexploitation. It also develops measures to reduce flooding risk. DETEC includes the Swiss Federal Office of Energy and deals with policy-related aspects of hydropower (promotion, strategies, perspectives) as well as the technical and safety aspects. The Swiss Federal Office for the Environment is responsible for the environmental aspects (residual water, protection of bodies of water).

The Federal Office for Agriculture (FOAG) is part of the Federal Department of Economic Affairs. FOAG promotes multifunctional agriculture, which makes a major contribution toward ensuring the provision of adequate food for the population; maintaining natural resources and the rural landscape; and maintaining a decentralized settlement pattern throughout the country (The Federal Authorities of the Swiss Confederation, 2011).

2.2. WATER MANAGEMENT

FOEN is promoting integrated catchment area management. It believes this is the best way to manage water resources and water bodies in a way that balances conservation and water needs.

In 2011, FOEN published *The Watershed Management: Guiding Principles for Integrated Management of Water in Switzerland*. Regulations around watershed management come from the federal constitution, the main objectives of water management and the vision of Water Agenda 21. The aim is efficient and sustainable realization of the main objectives through coordination. This guide says that integrated management of water in the catchments area is highly efficient and flexible. The integrated management of water is primarily based on the natural system. Watershed management can be adapted – in terms of space, content and organization – to different river systems and to the needs of different stakeholders. Goals and measures are also regularly reviewed and adapted to changing conditions if necessary.

In Europe and in Switzerland, perspectives are changing. Stakeholders are viewing the river system as a whole rather than looking to take small-scale, sectoral action. A few cantons are enshrining these principles in their legislation and implementing successful projects. Integrated watershed management focuses on the long term. By including stakeholders in the planning, building awareness and transparently balancing interests, better solutions can be found and implemented in the long term.

2.3. WATER POLICY AND LEGAL FRAMEWORK

Swiss water policy has been developing and promoting the concept of “integrated water management” in individual catchment areas. The *Guiding Principles for Swiss Water Courses* outlines specific measures cantonal, regional and local authorities should adopt and provides examples of good practice. The emphasis is on three development goals: adequate space, adequate water flow and adequate water quality (EEA, 2011).

Water protection in Switzerland has a firm legal basis in the Water Protection Act and the ordinance adopted under it. The Water Protection Ordinance defines the ecological targets and water quality requirements for surface and groundwater. These must be met at all times. It also

defines minimum residual flow levels for all water abstraction points, and states that existing water abstraction points must be rehabilitated to meet intermediate targets by 2012.

The Water Protection Act and Ordinance are currently being amended, focusing especially on the following issues:

- Assured financial support for surface water restoration, with the target of returning 4,000km of surface water to a more natural state within 80 years;
- Mandatory strategic planning of restoration activities;
- Rehabilitation of hydropower plants to ensure linear continuity for fish migration;
- Engineering measures to reduce the dynamics of hydropeaking (for example, retention basins);
- Measures to reactivate the bed-load balance.

To mitigate point-source pollution by micropollutants, the largest wastewater treatment plants in affected areas are to be upgraded. The corresponding legal basis is currently being established. Further research is underway to improve understanding of pollution from micropollutants.

Flood risk prevention includes preliminary flood risk assessment and hazard mapping, and the promotion of a modern flood protection policy, aiming to: ensure adequate protection of areas vital to livelihoods and economic development; limit economic damage with a comprehensive prevention strategy; improve the handling of uncertainties and residual or remaining risks; and understand rivers and streams as essential linking elements in landscapes and nature (EEA, 2011).

As a non-EU member, Switzerland is not bound to implement the Water Framework Directive (WFD). However the Swiss legal system has set comparable targets for water protection and management. In contrast to the WFD, which is based on planning periods with specified targets, the Swiss legislation has binding requirements including a set of national limits which must be adhered to at all times.

3. GEOPOLITICAL ASPECTS

As a member of the international commissions of the Rhine river basin and of Lakes Constance, Geneva, Lugano and Maggiore, Switzerland collaborates with its neighbouring states to achieve water protection goals and to implement programmes. It thus indirectly adopts certain principles of the WFD (EEA, 2011).
